STATE MANDATED ASSESSMENTS – PURPOSE, USE, and DATES

Universal Screening Grades K-8th, AIMS web, STAR Reading and STAR Math, HMH Math

These benchmark assessments will be utilized to identify students whose performance warrants further investigation. They determine who is likely to need additional assistance to reach grade level performance expectations. Parents will receive notification if the results indicate the child meets the requirements for additional academic support and intervention(s). If the student qualifies for intervention, parents will be notified of the progress every 4.5 to 5 weeks.

TCAP Grades 3-8 (English language arts, Math, Science, Social Studies)

These fully aligned assessments capture the depth and breadth of what students are learning-and have been learning in the classroom every day. The information from these assessments will provide educators, parents, and students with a big picture perspective on how they are progressing academically compared to their peers across Tennessee and better information about a student's strengths, needs and areas of growth.

This test will give the teachers and parents' valuable information to guide instruction, highlighting strengths and areas for improvement.

High School ACT Assessment Information and Purpose 2023-2024

Beginning with the graduating class of 2018, students enrolled in Tennessee public schools during their eleventh grade year must complete the ACT or SAT prior to graduation (see High School Policy 2.103). The students in Tennessee will have the opportunity to take a college entrance exam in the familiar surroundings of their own school, on a school day, at no cost to them. The test will be administered online.

Make-ups - October 17 - 18, 2023

Spring Junior Test - March 18 - 22, 2024

Assessments Purpose, Use, and Dates

TCAP End of Course Tests in English I, II, Algebra I, II, Geometry, and US History

These assessments help students demonstrate the skills they possess in order to meet college and work expectations. Rigorous questions used will measure students' abilities in writing, critical thinking, and problem solving. The reports generated from scoring will assist teachers in planning instruction and give parents information about academic gains, weaknesses and strengths.

It uses brief, valid, and reliable measures of reading and math performance in grades K-12. Parents will be contacted if an assessment is needed and the results will be shared.

Date of Administration- As needed by the student on an individual basis at the beginning of the school year and at the end.
