All Lawrence County students must complete 28 credits before receiving a Tennessee High School diploma and to be eligible for participation in any graduation exercises at any Lawrence County high school. **The following twenty-eight credits shall be required for students to graduate:**

End of Course Exams

All students will be required to take multiple-part TNReady assessment exams in 7th & 8th grade, Algebra I, Algebra II, Geometry, English I, English II, US History, and Biology. These exams will account for a percentage of the student's final grade in that course. See board policy for more information - students cannot choose to opt out of any state-mandated test.

ACT Test Requirement

According to state law, all students must take the ACT in order to fulfill graduation requirements. Students may not opt-out of any state-mandated tests. All students in the 11th grade are required to take the ACT test during the junior year on either a national test date or the state test date. State legislation requires the ACT exam to provide educators with diagnostic information to assist in developing

interventions for the purpose of increasing high school graduation rates and improving student preparation for postsecondary achievement (TCA 49-6-6001). All students are encouraged to do their best when taking the ACT. Many institutions and scholarship foundations use the ACT to award money for college.

GRADUATION REQUIREMENTS

Graduation requirements for Summertown High School students are set by the Tennessee Department of Education, State Board of Education, and the Lawrence County Board of Education. These requirements are reviewed and changed pursuant to the aforementioned entities' implementation of new requirements. For this reason, the requirements for each graduating class might differ to some degree. However, all requirements for graduation must be met in order to participate in the commencement exercises. Any student eligible for graduation must be in good standing with the school, i.e., all financial matters resolved; have satisfied the requirements for graduation as specified by SHS and the Board of Education; be free from any pending legal matters; have fulfilled any transition or early graduation stipulations as noted in such contracts. All students who meet the minimum requirements for graduation listed in Rules, Regulations, and Minimum Standards of the Tennessee State Board of Education and in accordance with the guidelines and requirements of the Lawrence County School System will be granted a high school diploma. Twenty-eight (28) credits are required in order to receive a diploma from Summertown High School. All students enrolled in the current school year that have met all minimum requirements for graduation and are in good standing with SHS are eligible to participate in commencement exercises. Any student under suspension, expulsion, or assignment to the alternative school may not be permitted to participate in commencement exercises, and any student who has legal matters pending may not participate without written permission from the principal of the school. As is the case with all school-sanctioned events, the SHS administration reserves the right to limit participation in said event(s) to guests, parents, and students in the Lawrence County School System.

What is the grading scale at SHS?

All courses are graded on a 100-point scale.

How are students recognized for excelling academically?

Students are recognized based on their four-year cumulative numerical grade average. Honors and Advanced Placement classes will not be weighted in any way. Pass/Fail courses will not be included in the numerical grade average. Students will receive Honors based on seven semesters in accordance with the following scale:

Parental Academic Assistance--Things Parents Can Do to Encourage Achievement

- Make clear that school is the number one priority for young people.
- Encourage your child to attend school daily.
- Encourage and supervise your child's studies at home.
- Encourage your child to take challenging courses in high school.
- Become involved with your child's school activities.
- Keep in touch with your child's teachers and attend Parent-Teacher Conferences each semester.
- Monitor system-wide progress reports and report cards.
- Help students plan/prepare for future goals--college applications, financial aid, and workforce plans.
- Stay informed of college and scholarship deadlines. Speak to the Guidance office regarding scholarship applications and deadlines.
- Stress the importance of regular attendance by scheduling appointments late in the afternoon so students miss very little school.
- Help to create an environment that values academic achievement.

Make-Up Policy

It is the student's responsibility to make up all subject matter covered during the absence(s). When a student returns following **any** absence, it is the responsibility of the student to bring all doctor/parent notes to the office and to check with all of his/her teachers to obtain missed assignments. The student will have **2** days to make arrangements with his/her teachers to complete the work missed. Students who have been suspended will have a maximum of **2** days after returning from suspension to complete all missed tests.

Students who must be absent from classes to represent the school in approved extra-curricular activities will not be penalized for those absences; these students will be considered in attendance. However, these students will be responsible for completing all classroom work that they missed on the day they return to class.

Class, Club Field Trips, Conventions, Workshops

Students must have a **C** average in each class, not considered, nor to be considered, truant or chronically absent due to absences for any reason, and have no in-school/out-of-school or school bus suspensions in order to attend any club or class-sponsored activity that requires missing any classes.

Arriving Late

When students arrive on campus late, they must report to the office and officially sign in and then report immediately to their assigned class. Once on campus, a student may not leave without permission and without going through the regular check-out procedure. Signing out without proper parental and administrative permission is not allowed. Three tardies are equivalent to one absence.

Student Attendance / Truancy / Excessive Absences

Parents of any student who meets the state of Tennessee's definition of excessively absent will be required to meet with school officials to develop an action plan to correct the attendance issues. Failure to meet or correct the problem could result in the parents being petitioned to court for educational neglect. In addition, any student who acquires more than 5 unexcused absences could be petitioned to court for truancy under state laws. See the LCSS board policy for more details.

CHRONIC ABSENTEEISM (Miss 10% or more school days)

The state of Tennessee determines a student is Chronically Absent once he/she misses 17 days during an academic year. The reason for an absence is irrelevant when the Tennessee Department of Education finalizes data for an academic year. As a result, SHS places chronically absent students on a probationary status for the academic year. Significant improvement in **Daily Attendance** is needed in order for a student to enjoy all the benefits afforded to LCSS students in good standing.

Students who do **not** demonstrate regular attendance during an academic year are subject to any or all of the following restrictions/notifications:

- Name submitted to Truancy Supervisor for monitoring;
- Name sent to Judge Ashley Duncan for review;
- Truancy Meeting at the school level and possible petition to court if improvement is not made;
- No issuance of the required truancy form to obtain a driver's permit;
- Possible Revocation of student Drivers License;
- **Loss of privileges within LCSS might include:**
 - Academic Honors, Renaissance Recognition, others;
 - ACT Incentives, Class or School Office Leadership position;
 - Loss of participation in extracurricular activities including athletics, dances, field trips, etc.
 - Loss of participation in clubs and organizations;
 - Loss of participation in senior year activities including, but not limited to, Prom, Graduation, Walk the Halls, and others;
 - Eligibility for in-house scholarship opportunities;
 - Loss of participation in Dual Enrollment with Columbia State or other post-secondary institution(s) grades 9-12. Participation in DE requires school permission. Poor attendance will be used in determining eligibility/granting permission.

Keep in mind that the **Tennessee Department of Education measures absenteeism as a student not in school.** The reason for the absence, excused or unexcused, is irrelevant in state reporting. A student who attended a school-sanctioned event and was coded incorrectly will be corrected. Attendance monitoring became part of the school accountability during the 2017-2018 school year.

Arrival at School

All students arriving before 7:40 a.m. must report to the cafeteria or gym. ***Students are not to be dropped off behind the cafeteria.*** Students that drive or ride in a vehicle **must** enter the building immediately upon arrival. Students are **not** allowed to sit in vehicles in the parking lot before or after school.

VISITOR INFORMATION

Visitors to Summertown High School are welcome during business hours which are from 7:30 A.M. until 3:30 P.M., Monday through Friday, when school is in session. All visitors must receive permission from the school administration and submit a valid picture ID upon arrival in the main office. Our campus is a "CLOSED CAMPUS." All visitors must report to the Main SHS Office immediately upon arriving on campus and before entering any other building, including the junior high building, tech building, and cafeteria.

What if a visitor wants to talk to a teacher?

Anyone who would like to meet with a teacher may do so by making an appointment during business hours. To make an appointment with any school official, please call 964-3539.

What if a visitor wants to talk to a student?

No one is allowed to talk with a student except his or her parents or legal guardian. Visitors should not come to the school to see a student. Visitors who are on campus for this reason will be asked to leave. Visitors who fail to cooperate will be arrested for trespassing. Students, parents, or visitors who have questions concerning Summertown High School are encouraged to come to the office or call the school anytime during business hours.

Students Leaving School Early

A parent/guardian or other designated person may come to the school and check out the student. The person picking up the student must submit a proper ID to school personnel. The ID will be scanned through the Raptor system (See Board policy). If anyone other than the parent/guardian is picking up the student, or the student drives to school, the parent must send a note to the school the morning of the impending check-out. The note should state the person slated to pick up the child and a daytime phone where the parent can be reached. School personnel will call the parent to verify the information in the note and permission for the student to leave.

Notes or phone calls alone are not acceptable for dismissal. The parent must send a note to the school on the day of the checkout. Students must turn the note into the office by 9:30 a.m. in order to give school personnel time to verify the information by phone with the parent. Students will not be allowed to check out for lunch and return to school. Students will not be allowed to check out during lunch and return without a doctor's note.

Parking on Campus

Driving to school is a privilege. Your behavior and attire in the parking lot should follow school rules at all times. Inappropriate decals, bumper stickers, or lettering on vehicles will not be allowed. Students are expected to enter the building immediately upon arrival. Students are not to sit in cars during school hours. Students may not return to the parking lot unless accompanied by an administrator or his designee. Students must purchase a school parking decal to legally park on campus and it must be displayed at all times while parked on campus. Failure to register your vehicle could result in the vehicle being towed at the owner's expense. Students must observe entrance, exit, and flow-of-traffic arrows as indicated. These precautions are for the security and protection of the students and their property. Failure to comply with these regulations might result in the loss of your driving privileges. All vehicles on school property are subject to search by the administration as authorized by state law (see board policy on student search). It is the student's responsibility to know the contents of the vehicle. Any prohibited items found in the vehicle will be considered the student's, and the student shall be held accountable for their possession. Cars parked inappropriately will be towed at the owner's expense. ***Parking in the church parking lot and behind the school is prohibited.***

Textbooks

Textbooks must be returned in good condition before grades will be issued. Fines will be assessed to cover the damage. Students will be charged for books they lose. Failure to return textbooks will be considered an adequate reason not to issue new textbooks. New textbooks will only be issued to students with a zero balance.

Chromebooks

All students enrolled at Summertown High School will have access to a Chromebook personal computer (provided they are in good financial standing with the school and system). The student and parent will be required to sign appropriate documents accepting all responsibility for the device. Those documents will be sent home, and the parents will be asked to agree before the device will be sent home.

Personal Property

Jewelry (including watches), any electronic devices, or other personal property should not be brought to school. Any personal property brought to school is the sole responsibility of the student. The school or school system will not be held responsible for lost or stolen items. No valuables should be left in lockers or P.E. dressing rooms. See board policy for any updates.

Social Media

In the rapidly changing field of technology, advances are being made almost daily that enhance student and teacher performance. However, with these advances come many dangers and pitfalls that can result in students and parents finding themselves in trouble with the school system and law enforcement. Parents and students are advised to avoid posting information on any social media outlets, such as Facebook, MySpace, Instagram, Twitter, and any other form of social media which might be deemed offensive, derogatory, defaming, threatening, or harassing toward fellow students, faculty, staff, and the school community in general.

Dress Code

All students are expected to abide by the LCSS Dress Code Policy:

BOTTOM WEAR - Bottom wear must be size appropriate (no sagging) and worn securely (waist and below) around the waist. Holes, tears, rips, or frays will not be allowed in bottom wear. Leggings and yoga pants may be worn as long as the top wear is 6" from the top of the knee.

SHORTS/SKORTS/DRESSES/SKIRTS - In grades 6-12, shorts, skorts, skirts, or dresses may be no shorter than 4" from the top of the knee. Dresses must also conform to the top-wear code (from the waist up).

TOP WEAR - All top-wear must be size appropriate. In grades 6-12, students shall not wear midriff shirts, tube tops, spandex, mesh, fishnet garments, backless tops, strapless tops, spaghetti straps, tank tops, or halter tops. Sleeveless shirts/blouses must fit around the arm. Shirts that expose a large area under the arms or expose undergarments are not allowed. Appropriate undergarments must be worn. No *cleavage*.

ALL APPAREL - Any other type of clothing, personal items, or tattoos bearing reference to alcoholic beverages, tobacco products, drugs, drug-related slogans, and/or any other wording, drawing, pictures, etc., which in any way can be interpreted as being sexually suggestive, obscene, or offensive, such as references to death, the occult, Satanism, etc., is not permitted in school or school-related activities; nor is "gang" related slogans, names, apparel, etc. Students are to wear clothing in the manner it was designed to be worn--i.e. clothing worn backward or inside out, and suspenders undone are not allowed. No see-through or cut-out clothing is allowed. Pajamas and house shoes may not be worn.

COATS - No trench coats, capes, overcoats, topcoats, military field jackets, or floor-length coats will be allowed.

HEADWEAR - No hats, bandanas, hoods, sweatbands, curlers, rollers, or sunglasses will be worn in the building except for medical reasons.

JEWELRY/ACCESSORIES - Students are not to wear jewelry, ornaments, or accessories which distract from the educational process or pose as a health or safety issue. Body piercing is limited to the ears and nose. Students are not allowed to wear gauges nor have septum piercings. No heavy metal chains (such as made out of steel, chrome, alloy, etc.) and look-alikes that are not formal jewelry are allowed around the neck, around the waist, or hanging from the waist into the pocket. Students may not wear metal-spiked apparel.

OTHER - Students are not to wear extreme facial makeup that is disruptive to the educational environment. All students are required to wear their hair in such a manner that is not considered unkempt, unclean, or impairing vision. Students are not to wear hair-sprayed or dyed in unnatural colors (such as blue, pink, green, yellow), spiked hair, or Mohawks.

SPECIAL DRESS - Schools may develop special dress days/special dress occasions for students at the discretion of the school administration (examples: cheerleaders, FFA, etc.).

SPECIAL SITUATIONS - If a student cannot comply with the standardized dress code based on religious beliefs, his or her parent or guardian may write a letter explaining the situation to the Director of Schools with a copy to the school principal. Each case will be dealt with on an individual basis.

Due to the fashion trends that are ever-changing, the school reserves the right to alter the dress requirement of students at any time during the academic year. On occasion, the school may lift these daily expectations. Only when expectations are lifted, the student may have permission to disregard dress code expectations.

In all matters pertaining to student clothing, accessories, and personal appearance, the final determinant of appropriateness will be principal discretion.

Cell Phones

Students are allowed to use their cell phones before school, during break, during class changes, during lunch, and after school. During instructional time, students are not allowed to use their cell phones. If a student's cell phone is visible during class time, the teacher may take up the phone and give it to the administration. The cell phone will be kept at school for three days for the first offense and 10 days for each additional offense.

School Property

School property is made available for the benefit of students. In order to ensure its longevity, students will be charged for the repair and replacement of any school property they damage whether accidental or intentional. School records or transcripts will be withheld until students' balance is zero. Outstanding balances on textbooks will be considered an adequate reason not to issue new textbooks. New textbooks will only be issued to students with a zero balance.

Medication

If under exceptional circumstances a child is required to take non-prescription or prescription medication during school hours and the parent/guardian cannot be at school to administer the medication, only the principal/designee will assist in self-administration of the medication if the student is competent to self-administer medicine with assistance in compliance with the following regulations.

Written instructions signed by the parent/guardian will be required and will include:

1. Child's name;
2. Name of medication;
3. Name of physician;
4. Time to be self-administered;
5. Dosage and directions for self-administration (non-prescription medicines must have label directions);
6. Possible side effects, if known; and
7. Termination date for self-administration of the medication.

The medication must be delivered to the principal's office in person by the parent/guardian of the student unless the medication must be retained by the student for immediate self-administration (i.e. students with asthma).

The administrator/designee will:

1. Inform appropriate school personnel of the medication to be self-administered;
2. Keep written instructions from parent/guardian in student's record;
3. Keep an accurate record of the self-administration of the medication;
4. Keep all medication in a locked cabinet except medication retained by a student per physician's order;
5. Return unused prescription to the parent/guardian only; and
6. Ensure that all guidelines developed by the Department of Health and the Department of Education are followed.

The parent/guardian is responsible for informing the designated official of any change in the student's health or change in medication.

A copy of this policy shall be provided to a parent/guardian upon receipt of a request for long-term administration of medication.

Athletic Policy

In order to participate, a student must meet the standards of the Tennessee Secondary Athletic Association and must abide by the rules that are established for team conduct. All regularly scheduled athletic events will be after school. No student will be dismissed from class for any reason without prior approval of the administration. Please see the TSSAA policy or Board Policy for more details. Truancy or chronic absenteeism could result in the loss of participation in athletics outside of practices.

Tobacco / Vaping

The state of Tennessee requires all public educational institutions to be tobacco-free spaces at all times, including all after-school events. Students who are caught in possession of or using tobacco will be subject to disciplinary action. This applies to any space on school property, including parking lots, vehicles, locker rooms, etc. Vaping is becoming a major concern on all campuses. If a student is found to be in possession of a vape on campus, he/she will be served a court citation through the SRO. All vapes that are collected will be tested for the presence of THC (Tetrahydrocannabinol). If a collected vape is found to be positive for THC, the student will be referred to a DHA (discipline hearing authority) on the grounds of a zero-tolerance offense for illegal drug paraphernalia.

SCHOOL BUS EXPECTATIONS & POLICY

Student conduct is of utmost importance to the transportation system. A student shall not exhibit behavior(s) that interferes with the rights of another student or the driver, or exhibit behavior that endangers the lives of others in transport. Riding a school bus is a privilege. That privilege may be taken away when a student demonstrates unacceptable behavior. Students that have been suspended from the bus cannot ride the bus that evening unless authorized by the presiding principal. Suspension from the bus means all bus services. Any criminal activity committed by a student or adult will result in an arrest.

BUS EXPECTATIONS

The following shall be observed at all times:

1. Be on time at the bus stop.
2. Practice safety to, on, and from the school bus each day.
3. Share a seat with any other students.
4. Remember that bus seats are to sit on and not for reclining.
5. Face the front.
6. Keep books and other articles off the aisle floor.
7. The rear door is for emergencies only. Use the front door to enter and leave the bus.
8. Respect the rights of your fellow students.
9. Talk to the driver as little as possible.
10. The bus driver is in command; respect and obey the driver.
11. Enjoy your ride. Be reasonably quiet.
12. You will be considered in school if you are riding the bus.
13. A student shall become ineligible for public school transportation after refusing to follow state and local rules and regulations pertaining to pupil transportation.
15. Any student who is disrespectful to the driver is subject to school and bus suspension and or expulsion.
16. Students will not be allowed to exit the bus anywhere other than at home or the original pickup point unless by a note signed by a parent and school official.
17. Students are not allowed to exit the bus to walk to or enter a vehicle unless by permission of a school official. A violation will be reported to the school official.
18. Student projects, etc. may be allowed provided the student can keep them in their possession. No glass items will be allowed. Animals, pets, etc. are prohibited.

SCHOOL BUS GUIDELINES AND EXPECTATIONS

1. Take your seat and remain there. No moving around.
2. Refrain from throwing any object on the floor or at others.
3. Throwing objects out of the window is not allowed.
4. Violations of safety procedures such as opening emergency doors or windows, pushing while exiting, etc. are strictly prohibited.
5. Possession and use of tobacco is illegal.
6. No drinks, eating, or chewing gum will be allowed on the bus.
7. Anything considered a weapon or used as a weapon will not be allowed on the bus.
8. Leaning out of windows is prohibited (arms, hands, legs, etc.).
9. Gestures or shouting at pedestrians or vehicles is prohibited.
10. A continuous violation of the expectations will result in an office conference, parent contact, and suspension from riding the bus.

Major offenses may include, but are not limited to: fighting, destroying property, threatening the driver, profanity, tobacco violation, or bullying.

Consequence(s) –

1st offense - 5-day bus suspension

2nd offense - 15-day bus suspension

3rd offense - suspension for the remainder of the school year

After the third (3rd) offense, the student and his/her parent or guardian must appear before the BOE's transportation committee.

Any student who has a weapon in his/her possession and/or possesses or uses drugs or drug paraphernalia on the school bus shall be reported to the principal, who, in turn, will contact the parent and law enforcement officials. The student will be subject to expulsion (from school attendance) for a period of one (1) calendar year.

The suspension of a student from riding the school bus shall follow the same procedures as for any other school suspension.

In all matters pertaining to this handbook, the administration of the school will be the final determinant. All effort is made to make sure the information contained in this handbook is accurate. The administration reserves the right to amend the information contained herein. All updated board policies can be found at www.lcss.us.
